#### Public Academic Reporters

The purpose of the SFA component is to collect information about financial aid provided to various groups of undergraduate students at your institution.

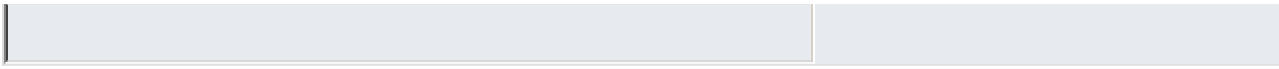
